#### Greenville Baptist Association Bylaws

#### Article I - Name

This body, a South Carolina non-profit corporation, shall be known as the *Greenville Baptist Association, Inc.*, and is hereinafter referred to as "the Association."

#### Article II - Vision and Mission

The vision of the Association is to establish, equip, empower, engage, and encourage member churches to reach people, grow disciples, and minister in the name of Jesus Christ.

The mission of the Association is to assist churches in:

- 1. Establishing new churches for reaching the lost in our area and helping re-establish existing churches that are seeking to minister in changing circumstances.
- 2. Equipping believers to be effective in Kingdom work by offering training in multiple areas of church ministry.
- 3. Empowering believers to serve the Lord through spiritual gifts discovery and development and the development and presentation of ministry opportunities.
- 4. Engaging believers in active, life-changing ministries, both locally and globally.
- 5. Encouraging believers through prayer, relationships, and partnerships to fulfill God's vision for their churches.

#### **Article III - Membership**

Section A – The Association is a self-determining fellowship of autonomous Baptist churches, which are voluntarily bound together for the advancement of the Gospel of Jesus Christ.

Section B – Membership in the Association is held by churches. Member churches participate in the governance of the Association in two ways:

- 1. By sending their pastors and duly elected lay representatives to Executive Committee meetings as voting members thereof.
- 2. By duly electing and sending church members to regular and special Association business meetings as voting messengers.

Section C – An individual must be a member of a member church in order to be eligible to serve the Association in the capacity of officer, committee member, team member, or trustee upon his/her nomination and election in an Association business session.

Section D – Member churches shall be entitled to send voting messengers to regular and special Association business meetings as follows:

- 1. Three messengers for the first one hundred church members or fraction thereof.
- 2. One additional messenger for each additional one hundred church members or fraction thereof.
- 3. No church shall be entitled to more than fifteen messengers notwithstanding the above.

Section  $\mathbf{E}$  – Membership in the Association shall be comprised of:

- 1. The churches which are members of the Association on the date of the adoption of these Bylaws.
- 2. Those churches subsequently admitted according to controlling provisions of the Association's governing documents and policies.

Section  $\mathbf{F}$  – Churches which are not members of the Association may apply for and be accepted into membership of the Association according to the following:

- 1. The Church Relations Committee shall serve as the Association membership committee.
- 2. Application for membership shall be made in writing and referred to the Church Relations Committee.
- 3. The Church Relations Committee will evaluate the applying church's eligibility for membership and make a recommendation to the

Association according to any policies and procedures which the Association may, in its discretion, officially adopt in its Bylaws or otherwise, and also according to the following criteria:

- a. The applying church must conduct its primary worship and educational functions within the confines of the geographic region generally accepted to be the area served by the Association.
- b. The applying church must be Baptist in polity and practice.
- c. The applying church must be found, upon examination by the Church Relations Committee, to be supportive of the Association's

vision and mission.

d. The applying church must be found, upon examination by the Church Relations Committee, to be in general agreement with the *Baptist Faith and Message* and the purposes and intentions for which it was adopted.

Section G – Any member church may withdraw from the Association at its pleasure. Official notice of withdrawal should be communicated in writing to the Church Relations Committee.

Section H – Should a motion be made in a regular business session of the Association to dismiss a church from membership, it shall be referred to the Church Relations Committee. When the matter comes back before the Association for a vote after a one-year period expires, the Church Relations Committee shall make a report and recommendation to the Association regarding the motion. The Association may accept or reject the recommendation of the Church Relations Committee.

#### Article IV – The Association

Section A: The principal office(s) of the Greenville Baptist Association shall be in Greenville County, South Carolina.

**Section B:** The Association shall convene annually in October or at such time and place as may be recommended by the Annual Meeting and Worship Committee. Messengers present shall constitute a quorum.

Section C: A messenger shall speak no more than twice on any subject and shall confine himself to the subject under discussion.

Section D: The parliamentary authority of the Association shall be *Roberts Rules of Order* (latest revised edition). The moderator shall appoint a parliamentarian to serve during his term of office.

**Section E:** Special meetings of the Association may be called by the director of missions and moderator or by majority vote of the Executive Committee with at least a two-week written notice to each church giving purpose of meeting. Messengers present shall constitute a quorum.

#### Article V – Officers

Section A: The officers of the Association are the moderator, vice moderator, treasurer, clerk, and such other officers as designated by the Association.

**Section B:** The officers shall be nominated by the Committee on Nominations and elected by the Association in annual session. The moderator is not eligible to succeed himself unless he is filling an unexpired term. The terms of service for elected officers shall begin at the conclusion of the October Annual Meeting.

Section C: Any officer may be removed at any time by affirmative vote of the Association in session and a two-week notice of such proposed action has been given.

**Section D:** The moderator shall serve as moderator of the Association and the Executive Committee, and shall preside over all Association meetings and ensure that order and decorum are observed. The moderator shall be ex-officio member of the Committee on Nominations. The term of office of moderator shall be one year.

**Section E:** The vice moderator shall serve as vice moderator of the Association and Executive Committee and shall preside during the absence or at the pleasure of the moderator and be ready to help wherever he is needed. He shall fill the vacancy arising from the resignation or removal of the moderator during the year. The term of office of vice moderator shall be one year.

Section F: The office of treasurer shall be filled by the director of missions. The duties of the treasurer are listed in Article VIII.

Section G: The clerk of the Association shall serve the Association in session and the Executive Committee. Responsibilities are:

- 1. Keep accurate records of all meetings.
- 2. Prepare summary of Executive Committee meetings for publication in the Messenger.
- 3. Publish annual minutes.
- 4. Mail Annual Church Profile to church clerks.
- 5. The clerk also may serve as historian

#### Article VI – Executive Committee

**Section A:** The Association Executive Committee shall consist of the moderator, vice moderator, clerk, treasurer/director of missions, the pastor of each church (or his designee), one lay person from each church, and a representative of each mission in the Association. Each church shall duly elect a lay person from its membership to serve on the Executive Committee and report its election to the Association on the Annual Church Profile.

**Section B:** The property and business of the Association shall be managed by the Executive Committee of the Association. Between meetings of the Association the Executive Committee shall have the full power and authority to act on behalf of the Association except for buying and selling real estate, borrowing money, and doing all such lawful acts and things as are not by statute or by these Bylaws directed or required to be exercised and done by the Association in session. The Executive Committee shall render full report of all meetings and of all business transacted to each meeting of the Association, and a summary shall be printed in the *Messenger*.

Section C: The Executive Committee of the Association shall convene as needed to consider the ministries of the Association and to assist the Association staff with these ministries. The moderator or a majority of the Executive Committee members may call a special meeting with a two-week written notice giving purpose of meeting.

Section D: After due notice of the meeting has been given to the members of the Executive Committee, those present shall constitute a quorum.

#### Article VII- Bylaws, Policies, and Procedures

The Association shall have the authority to adopt bylaws, policies, and/or procedures governing all aspects of the work of the Association.

#### **Article VIII - Director of Missions**

The director of missions shall be employed for an indefinite tenure of service. The director of missions shall give guidance to the ministries, activities, and programs of the Association and shall serve as treasurer for the Association. The director of missions shall be elected by the Association at a regular or special meeting upon the recommendation of a search committee that shall be elected by the Executive Committee. The director of missions is directly responsible to the Association. Areas of responsibility are:

- 1. Chief administrator, planner, and resource person for the Association.
- 2. Ex-officio member of all teams and committees.
- 3. Counselor and advisor to the Association staff, ministers, and leaders of the churches.
- 4. Responsible for receiving the funds for the Association, administering the budget, keeping accurate records, and reporting to the Association in annual session and in Executive Committee meetings.

#### Article IX – Administrative Committees

Section A: Administrative committees are committees that have continuing functions in the total administration of the Association.

**Section B:** A person shall serve on no more than one committee of the Association unless he is a member of a special committee. A committee member shall be eligible to succeed himself. A committee member who finds he cannot serve is asked to inform the Committee on Nominations in order that he may be replaced.

Section C: Terms of service for elected committee members shall begin at the conclusion of the October Annual Session.

**Section D:** Special committees, teams, or task groups may be developed at any time by the director of missions and officers of the Association. These groups shall have a one-year term of service unless otherwise stated.

Section E: All administrative committees shall have six (6) members, unless otherwise stated, with two (2) elected each year for a term of three (3) years except the Committee on Nominations whose members are appointed as outlined in Item 4a below. Committees and their responsibilities are:

#### 1. Annual Meeting and Worship Committee

- a. Working with the Association staff, this committee shall plan the program for the annual meeting for inspiration and for promotion of Association ministries.
- b. Recommend the time and place for the annual meeting.
- c. Recommend the preacher and the alternate for the annual meeting.
- d. Responsible for all arrangements for the annual meeting.
- e. Prepare and present resolutions of appreciation as appropriate.

#### 2. Bylaws Committee

- a. Annually read through the Bylaws in order to keep the document current with the activities and ministries of the Association.
- b. Study any proposed change or revision and bring a report to the next meeting of the Greenville Baptist Association.

#### 3. Church Relations Committee

- a. Develop the process and guidelines for the admission of new churches to the Association. The process and guidelines shall be consistent with the Bylaws and shall be approved by the Executive Committee.
- b. Recommend new churches at annual meeting or at meetings of the Executive Committee as defined by committee guidelines.
- c. Serve as a Credentials Committee if a question concerning messengers should arise.
- d. Relate to any church named in a motion of dismissal. Any motion for dismissal must be referred to the Church Relations Committee. The Church Relations Committee will report at the next annual meeting.
- e. Develop a process of negotiation to be followed with churches named in motions of dismissal.
- f. Work with churches that are in conflict and request assistance.

#### 4. Committee on Nominations

- a. The Committee on Nominations shall be composed of six members with two appointed each year for a three-year term. The outgoing moderator shall appoint the two new members, and he shall name the chair of this committee.
- b. The Committee on Nominations shall recommend to the Association the personnel of all special and administrative committees, and the Marietta Baptist Camp and Conference Center trustees.
- c. As needed, work with the Association Staff and Team Leaders for Associational ministries.
- d. Nominate moderator, vice moderator, clerk, and historian to the Association in Annual Session.
- e. Ministry Teams may be added or deleted as needed and approved by the Committee on Nominations.

#### 5. Finance Committee

- a. Study the financial needs of the Association.
- b. Present a proposed budget to the Association in the October Annual Meeting.
- c. Give oversight to administration of the Association budget.
- d. Care for any financial emergency by bringing recommendations to the Executive Committee of the Association.
- e. Promote the Association budget in such a way as to solicit support from all the churches.
- f. Review annual audit.
- g. Meet with the director of missions as needed.

#### 6. Personnel Committee

- a. Develop, maintain, and implement Guidelines for Personnel Manual.
- b. Work with director of missions to develop and recommend salaries and benefits for Association staff to Finance Committee.
- c. Work with director of missions to prepare position descriptions and update them as needed.

#### 7. Property Committee

- a. Inspect and inventory Association properties.
- b. Develop and implement programs of preventive maintenance.
- c. Work with staff to develop policies for the use of Association facilities and equipment.
- d. Represent the Association in matters related to property.

#### Article X – Marietta Baptist Camp and Conference Center

- 1. Marietta Baptist Camp and Conference Center is a partnership between Greenville Baptist Association and Three Rivers Baptist Association.
- 2. Each association shall have six trustees, two elected each year; and each trustee shall serve a three-year term.
- 3. Trustees shall be eligible to succeed themselves but serve no more than two terms consecutively.

#### Article XI – Financial and Fiscal Policy

**Section A:** The Association and its ministries and organizations shall operate on a unified budget. Each church shall be expected to contribute its proportionate share of the annual budget to defray the expenses of the promotional, educational, and missionary activities of the Association. Contributions on a monthly basis are requested of the churches.

Section B: The Finance Committee will promote the Association budget.

Section C: Association organizations may not solicit offerings except on prior approval of the Executive Committee.

Section D: The business year of the Association shall be January 1 through December 31.

Section E: Each year the finances shall be audited by a certified public accountant and a report made to the Executive Committee.

#### Article XII - New Work Properties and Assistance Fund

The New Work Properties and Assistance Fund is established to allow the Property Committee and the Finance Committee of the Greenville Baptist Association to borrow money against donated church property and administer these funds for the upkeep of these properties and for other New Work needs.

#### Article XIII – Annual Reports

**Section A:** The churches affiliated with this body shall be expected to furnish annually the information requested by the Annual Church Profile and shall endeavor to get this to the clerk no later than fifteen (15) days prior to the October meeting.

Section B: Each ministerial staff person employed by the Association or authorized to act as an agent for the Association shall submit an annual report giving clearly the facts of his/her ministry.

#### Article XIV – Legal Representative

Section A: The moderator and clerk shall sign all legal documents as directed by the Association or its Executive Committee.

Section B: The moderator and clerk shall perform such other functions and duties as directed by the Association or the Executive Committee.

#### XV – Historian

Section A: Gather and preserve Association records, documents, and articles of historical importance.

Section B: Periodically publish articles that will make the membership more aware of our heritage.

#### **XVI- Amendments to Bylaws**

These Bylaws may be altered or amended by the affirmative vote of a majority of the messengers present at:

- 1. Any regular meeting of the Association provided a written notice is given two weeks prior to when proposed changes are to be considered.
- 2. Any special meeting of the Association provided the written notice of such special meeting includes a copy of the proposed changes to the Bylaws that are to be considered.
- 3. Any proposed changes or revisions must be in accordance with Article IX, Section E, 2b.

#### 154<sup>th</sup> Annual Meeting Minutes October 23, 2014 Monaghan Baptist Church

- Presentation of music by Rev. Danny Culbertson and the Monaghan Church Band.
- Moderator, Rev. Bryan Cox, pastor of New Hope, called the 154<sup>th</sup> Annual Meeting to order.
- Rev. Tom Rushing, pastor Deaf First, read Matthew 28:18-20 and had prayer.
- Rev. Barry Dilworth, pastor Monaghan, welcomed everyone.
- Verla Bennie, Clerk of GBA, member Mauldin First, read the following motion of organization, "I move that the messengers presently registered and those who are still to register constitute a quorum for conducting the 154<sup>th</sup> Annual Meeting of the Greenville Baptist Association." The motion was seconded and approved.
- Rev, Danny Culbertson, minister of music, Monaghan, presented motion to accept the agenda. This was seconded and approved.
- Moderator, Rev. Bryan Cox, recognized the following visitors: Randy Creamer of South Carolina Baptist Convention Disaster Relief; Bob Deaton of Baptist Foundation of South Carolina; Matt Thomas, director of Camp Marietta; Chris Rondeau of Man in the Mirror Ministries; and Dr. Bob Kline of Anderson University.
- Moderator, Rev. Bryan Cox, brought the following to the platform and recognized as new pastors in our association: Fred Garner of Riverview and Deane Harrison of Rockvale.
- Rev. Stephen Miller, Pendleton Street, let the congregation in music.
- Rev. Danny Culbertson gave the Annual Meeting and Worship Committee Report, giving appreciation to Monaghan Baptist for hosting this year's meeting. Called for question, voted in favor to adopt report.
- Rev. Daniel Lee, Bethel, presented Church Relations Committee report. There are three (3) churches seeking partnership with Greenville Baptist Association. Capstone motion presented, question called, voted to accept into Association. Oak Point Church motion presented, question called, voted to accept into Association. Heritage Church motion presented to accept into Watchcare until 2015, question called, voted to accept into watchcare. Rev. Lee referred to page 24 of the annual meeting booklet with the status that GBA must be doing something right since our percentage of new starts is higher than the national average over the last 10 years! Rev. Lee is rotating off this committee but made a strong statement that he believes in the Cooperative Program and Greenville Baptist Assocation. Missions begins at home.
- Moderator, Rev. Bryan Cox, welcomed the pastors of the three (3) new churches.
- Rev. Danny Burnley, Laurel, presented Committee on Nominations Report. Everyone who was asked to serve agreed and the committee only had to meet one time! Question called, voted to accept report.
- Rev. Joel Thrasher, GBA staff, presented the Finance Committee Report. In April 2014 and extra payment of \$49,000 was paid on the building loan. It is planned to make at least one extra payment per year. Nothing from the rent of the building is applied to the work of GBA. Budget is presented in the booklet on pages 26-28. There is a 2% cost of living increase. There is a decrease in the line item of salary due to Melissa Samples working just a few hours per week. Staff support benefits is a 5% increase over last year's budget due to actual costs of benefits. The plan of NAMB to phase out support over a 5-year period shows 2015 is year three (3). The challenge to churches is to financially support GBA. Question called, voted to accept the 2015 budget.

- Mr. Jack Dill, member Northgate, presented the Property Committee report. There is a good working
  relationship with the Greenville Dialysis and GBA. The expenses have been kept to a minimum this
  year. The tenant shared the cost of having the shrubs and trees trimmed by the retainer wall. Motion
  to accept the report, question called and voted to accept report.
- Miscellaneous business short video from D.J. Horton, president of the South Carolina Baptist Annual Convention.
- Rev. Robbie Sox, Brushy Creek, led congregational singing.
- Rev. Eddie Howard, Hillside, presented the DOM Search Committee report. Proverbs 16:9 keep your eyes fixed in the right direction. The team has met, prayed and struggled. The intent is not to just find a person but to find God's man for the position. They are still looking, still asking and will continue to work. The team asked and needs desperately everyone to continue to pray and ask God to speak to that person as well.
- Rev. Dan Messer, GBA staff, reported on the Hispanic ministry of the Association. In the ministries overall there is a weekly average attendance of 325 with 33 baptisms this year and one (1) ordination. Rev. Messer presented the pastors of each Hispanic church including Christ the Open Door Church which is ministering to people from Guatemala. Greenville has the largest percentage of Hispanics in South Carolina. Truly the harvest is plenty but the workers are few. Rev. Messer led in prayer to multiply and bless them.
- Rev. Joel Thrasher gave update on GBA. "How's it going?" has been frequently asked. It's going well.
   Have a great staff who love Jesus, know their jobs and do them well. It's not been without challenges Camp Marietta had a problem with DHEC and a well. Only one major church conflict this year so far! The Lord is working through it. Things are going well due to volunteers. Things are going well during a year of transition and moving forward. Things are going well because of churches. The ACP shows 699 baptisms last year and 730 this year so far (30 churches not responded yet). The staff prays for specific churches each week.
- Joel then thanked Bryan Cox for his serving as Moderator this past year. Bryan has a heart for pastors. Joel then presented Bryan with an engraved gavel in appreciation for his service.
- Bryan Cox thanked everyone for their reports.
- Robbie Sox led the congregational singing.
- New officers were presented, Benny Littlejohn, moderator; Jerry Zapata, vice moderator; Verla Bennie, clerk; Wanda Bridwell, historian.
- Dr. Benny Littlejohn, Eastlan, closed the meeting with prayer.

#### Interim Report

Webster defines interim as "a period of time between events." Or, in our case, between persons. It has been my privilege to serve as the Interim Director this year. Allow me to share some thoughts and observations.

- 1. You have a great staff! In times past, when we experienced staff reductions, I have seen them step up and assume more responsibilities. This time has been no different. Wanda, Karen, Dan and Melissa continue to effectively serve the churches. Churches for whom they deeply care. Something we have done this year is intentionally pray for our churches during staff meetings. We have asked for prayer requests/praises and taken them seriously. Every church has been specifically prayed for. It brings me joy to count the staff not only as colleagues, but family.
- 2. Bryan Cox has served well as Moderator. He has also taken on some responsibilities not normally associated with that role. Early in the year, Bryan expressed concern over fellowship among ministers. What resulted from our conversations were the regional ministers' fellowships. Basically, we divided the Association into eight geographical groups. Each group has had a fellowship opportunity. There have been no agendas, other than small group fellowship, conversation and prayer. I deeply appreciate Bryan and his service as our Moderator during this interim time.
- 3. Committees! I know...committees sometimes have a bad reputation. Sometimes that reputation is well deserved. That is not true of GBA. Ours have functioned smoothly. I can honestly say that I am thankful for the men and women who serve on the various committees and help to move GBA forward.
- 4. Of course, the Association would not exist were it not for the churches. We are a large Association with 114 congregations. We are a diverse Association in language, structure, worship style and more. We have large churches, small churches and everything in between. We have churches that are actively involved in GBA, and some who aren't. We have churches that faithfully support GBA financially, and some who haven't contributed a penny in years. We have growing churches, plateaued churches, and dying churches. Thankfully, there has only been one significant church conflict this year of which I am aware. We also have fewer than normal churches without pastors. We desire to see every church functioning as a vital, disciple-making, body of Christ followers.

Many years ago, I was told that the churches are both the owners and clients of the Association. That remains true today. We are here to resource and serve the churches. We are your mission partner!

#### **Missions Strategy 2014**

Revelation 7:9: "After this I looked, and there before me was a great multitude that no one could count, from every nation, tribe, people and language, standing before the Lamb..." He looked. He saw the great, ethnically diverse multitude. Who do you see when you look around?

We know of around 87 nationalities, speaking 39 languages, living in Greenville County. Best guess is that somewhere around 4,000 – 6,000 Arabs are here. Over 3,000 Asian Indians, 4,500 Deaf, 8,000 French, and 1,500 Japanese. Then there is our Hispanic population that continues to see rapid growth. And the list goes on and on. Did you know about the Hindu center in Mauldin? Did you know about the Islamic Masjids on Wade Hampton Boulevard, East North Street and Pete Hollis Boulevard? Did you know that the IMB lists Greenville as one of the top 100 most ethnically diverse areas in America?

#### <u>Local</u>

*Church Planting* must be an important part of what we do to transform the changing populations in Greenville County. There are currently 19 church plants in the GBA! 13 are language congregations. *Hispanic Ministries* are needed more than ever with our rapidly growing Hispanic communities. One new Hispanic church plant was started this year and two new Hispanic Bible Studies. Dan Messer provides excellent leadership to this ministry. With our increasing ethnicity, with our local church involvement lower than it was 25 years ago, with the increasingly irreligious neighbors around us, we must be planting new churches!

*Mission Greenville* This year we partnered with an organization called *Mission Serve* as part of our *Mission Greenville* ministry. Edwards Road church does a great job of housing the participants and hosting the project. Seven host churches fed the crews. The partnership with the City remained strong. We are also excited that Greenville County is a partner with us now. Approximately 70 participants from three churches were involved. The crews completed seven roofs. Thanks to all those who are involved in this ministry. The 2015 dates are: June 21–27.

**Day Camp for Deaf Children** continues to make a difference in the lives of the campers, staff and families. The involvement of our deaf adults is a huge plus. We had 11 campers and nine volunteers. Brushy Creek hosted the camp. Day Camp returns on June 15–19, 2015.

**Crisis Centers**: Eastside, Westside, and Golden Strip Emergency Relief. The centers are staffed by more than 2,000 volunteers from 30+ churches. Spencer LeGrand continues to provide effective leadership for the Eastside Center. The same can be said of Jim Barnette at the Westside Center. The Golden Strip Center is a partnership with the Golden Strip Emergency Relief and Resource Agency coordinated by Julia Bayne. Food is provided by churches, groups, and individuals as well as purchased from various locations. The centers spent \$24,434 on food. We received \$7,175 from the World Hunger Offering to assist the centers. Even though the economy is rebounding, the centers assisted 7,310 families (19,460 individuals) with basic needs including food, clothing and financial aid this past year (September 2013–August 2014). Thanks to all who make these ministries possible.

*Multihousing* ministries are nothing new to Greenville. For years, there have been churches and teams doing a wide variety of ministries primarily in low-income communities. That will continue as churches have a passion for impacting those communities. We continue to be supportive of *Apartment Life* and *CARES Teams*. More and more congregations are also seeing multihousing communities as serious mission fields in our own backyards. With over a third of our population living in some kind of multihousing, we must!

*Woman's Missionary Union* continues to provide valuable training, encouragement and ministry opportunities for our churches. I don't know what we would do without the faithful WMU missionaries in the Association and churches. Marcie Malone, from Mauldin First Church, serves as the Director.

Thirty-eight churches provided 1,408 *prisoner packets* for Christmas. Thanks to Pat Bradshaw from West Gantt FBC and other volunteers for all your help. Others helped Chaplain Andy Cooper at Perry distribute the packets to all the inmates there. Prison ministry is not just about Christmas packets. There are other volunteers in our churches who are actively involved in ministry with inmates, families of inmates as well as those who work within the correctional system. Multiple churches provided useful items such as paper goods, personal care items, health care items, school supplies and clothing for numerous agencies and organizations within the Greenville area. Sixteen churches provided 311 *ministry kits*. Thanks to all who prayed, gave and worked on these projects.

**Baptist Collegiate Ministries** is an important outreach and discipleship arm of our churches to college students. Ryan Brooks serves as the part-time Campus Minister at Furman. Shenita Frazier and Brian Bowman do a great job working with the students at Greenville Tech. Their reports are listed elsewhere.

#### <u>Regional/National</u>

**Disaster Relief** volunteers were on the road again. Our Disaster Relief coordinator is Jim Whitworth, from Origins church. Our Mud-Out unit was in Florida, and also much closer to home. With all the local flooding this summer, volunteers responded to needs in the Pelham Road area. Jim continues to serve effectively as President of the local **VOAD** (Voluntary Organizations Active in Disaster) organization.

We are committed to maintaining a partnership through *Appalachian Regional Ministries*. However, that partnership is in the process of being re-evaluated. We are also beginning to explore new opportunities related to church planting in *Hartford, Connecticut*. Stay tuned for more information.

#### <u>Global</u>

We continue to seek opportunities to make a global impact. Our partnership in *Honduras* is in its third year and saw one team go there this summer. Mission team members came from Brushy Creek and Origins. It was our smallest team, with four members, yet much work was done. We committed to assisting *Jesus the Grace of God Church* as they construct their first building. During our week there, we worked with them to finish the exterior walls so they can begin work on the roof. We plan to return there next year. Those dates are July 24–31.

*Missions Strategy* relates to New Work, Hispanic Outreach, Mission Partnerships, Community Ministries, Summer Ministries, Demographics, WMU, Men's Ministries, Baptist Collegiate Ministries, Multihousing Ministry and a few other things. I am so thankful for Wanda Bridwell who tries to keep us straight as Missions Strategy Assistant. Times of transition can be fearful and stressful. They can cause us to slow down. They can also be times of renewed energy and excitement. We can embrace it and move forward. We must! So, we move forward as we believe God is leading. We move forward knowing that the top 25 most unreached areas of the Upstate are all in Greenville County; that the most unreached zip code in the state is 29601; that at least 70% of our entire population is unreached and that 40% of our population is not only unreached, but uninterested. This is no time for fear. We must move on!

#### Hispanic Annual Report – 2014

This past year has seen the Lord bless the Hispanic Ministry. There was one new Hispanic church plant that began: Iglesia Bautista Hispana La Roca (2014). Two new Hispanic Bible studies began: Mauldin First (May 2014) and Simpsonville First (June 2014). The past year had an average attendance for worship of 306 and 33 baptisms within our Hispanic works. The Annual Evangelism and Mission Conference held at White Oak Conference Center had nearly 800 in attendance from four different states. As the Hispanic population grows there is a tremendous need for Hispanic leaders. The words of Jesus in Matthew 9:37-38 ring loud today: "The harvest truly is plentiful, but the laborers are few. Our Hispanic pastors are: Jerry Zapata—Iglesia, Ernesto Chaparro—Berea Heights, Felipe Hernandez—Cristo la Puerta Abierta, Elmer Rivera—Cherrydale and Mauldin First, Carlos Ruiz—Brushy Creek, Carlos Galarza—Laurel, Maciel Marquez—Rocky Creek, Greg Somers—La Roca, Rafael Jauregui—Simpsonville First, and Samuel Kioko—SonPoint.

#### WOMAN'S MISSIONARY UNION Auxiliary of Greenville Baptist Association 2013-2014 Director's Report

#### "The Story Lives On"

We spent this year continuing the celebration of the 125 years of Woman's Missionary Union from its establishment in 1888 and through its growth across the years – not just in numbers of individual members and organizations- but also the development of our missional objectives. These growth features give us reason for celebrating and still advocating the premise that missions education and missions involvement are vital for Christians. Our watchword, "As for us, we cannot help speaking about what we have seen and heard." continues to be a challenge, even as we move into a new emphasis period.

Woman's Missionary Union always champions the Season of Prayer for State Missions and the Janie Chapman Offering in our churches. Due to changes in North American Mission Board policies, we believe that emphasis on supporting our South Carolina and associational missions personnel and being involved is very important to missions in our state.

On Saturday, October 5, happy voices of about 440 GA's, former GA's, future GA's, and "wanna be" GA's rang through the hall of First Baptist Church-Mauldin. The occasion was the Upstate South Carolina celebration of the 100<sup>th</sup> birthday of GA's (Girls Auxiliary and Girls in Action). Praises for past years and prayers for the future were lifted in support of these organizations for young girls.

October 24, several members of our Leadership Team participated in the retirement reception at First Baptist Simpsonville for Dr. Ron Davis, former Director of Missions. They later attended the 153<sup>rd</sup> Annual Meeting of Greenville Baptist Association. The Area Directors had contacted church WMU leaders to encourage local church attendance for both events.

Our team sponsored a WorldCraft party on October 10 at Northgate Church. Proceeds from all purchases go to support national Woman's Missionary Union involvement in providing fair-trade wages and support to trades people in impoverished areas, thus expanding the fight against human trafficking.

November 4 and 5 marked the dates for Baptist Women around the world to pray together for women everywhere and for the advancement of Christ's Kingdom. Clear Springs, Edwards Road, Parisview, West Gantt First, and Woodside Churches hosted five meetings in our Association: 168 attended and \$539.61 was forwarded to the Women's Department of the World Baptist Alliance to support women's work worldwide.

We participated in the sending of Prisoner Christmas Packets to Columbia for distribution throughout the South Carolina Correctional facilities. We publicized the project and led local churches to support this annual South Carolina activity, and then assisted in checking 1,550 packets collected at the Greenville Baptist Association Office.

Monaghan Church Women on Mission hosted our "Days of Our Lives" Annual Focus on WMU Dinner on February 13 with 241 attending. Kimberly Sowell, author and speaker of Kingdom Heart Ministries in Lancaster gave us many heart-stirring thoughts about our part in the story of Christ and His Kingdom work. Our 125<sup>th</sup> WMU Anniversary commemoration quilt, made up of squares provided by WMU organizations of Greenville Association, was presented and dedicated. This beautiful quilt will travel to the various churches that participated and eventually placed for permanent display.

March 21–22, four of our Leadership Team attended the SC WMU Missions Encounter and Annual Meeting at Calvary Church in Florence. Rosalie Hunt, author, historian, and recording secretary of WMU SBC, and Debby Ackerman, president of WMU SBC, portrayed early leaders in the formation of Woman's Missionary Union SBC and SC WMU. Personal stories by North American and International Mission Board missionaries, regarding WMU influence on their lives, reminded us of our own responsibilities to influence lives.

On April 24, 85 ladies and helpers were welcomed and hosted by Women on Mission members at Simpsonville First Church for the Annual Spring Meeting of our Auxiliary. Lorie Spann, a former missionary kid and a missions volunteer, spoke on WMU influencing her family's missionary lives earlier and now. Wanda Morris, representative and former president of SC WMU, spoke on WMU objectives. A "Triple A" certificate of accomplishment was presented to Northgate Church, with Nancy Stephens accepting.

On Saturday, May 31, our first myMission Spa Day was held at Woodside Church with approximately 48 participating. The day was an enlistment event directed to younger women of local churches, possible prospects for a new WMU organization. Other events will be held in 2015.

Two of our team members participated in a mission trip to Jamaica to assist Dr. and Mrs. Vincent Fletcher with Vacation Bible School and training at Refuge Baptist Church of Duncan. Another trip is already in the planning stage.

Five members attended the August 23 Mprove Church WMU Leadership Training session at Irmo First Church.

The Greenville Auxiliary held its annual Church WMU Leadership Training on August 28 at Northgate Church. After a box supper, 56 attended the age-level conferences.

Throughout the year, our Leadership Team had ongoing contact with local churches in support of ongoing and upcoming associational and state missions activities. One of our purposes is to give support and assistance to Woman's Missionary organizations in our churches. We plan to visit with these groups and church staff members during the coming year to offer our help and express our appreciation for their support. The special events we sponsor could not be possible without their help. Also, we appreciate very much the staff at the Greenville Baptist Association Office. Their assistance and support is valuable to our team and our tasks. We look forward to our all working together in the new year under our new emphasis <u>ALL FOR YOU: Surrender, Sacrifice, Serve</u> and the challenge from Mark 8:34, "Then He called the crowd to Him along with His disciples and said: 'Whoever wants to be my disciple must deny themselves and take up their cross and follow me.' "
